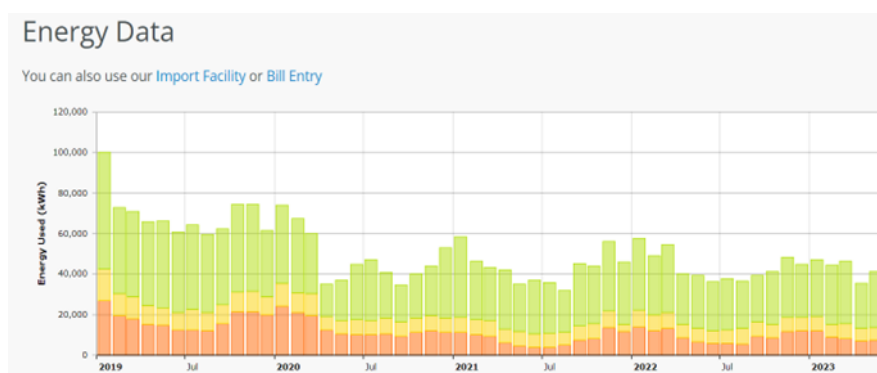
Emissions reduction targets

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We are currently in the process of collating our Carbon Emissions through Enistic (confirmation of this attached) using the Plato platform. Once we have baseline and 2022 data we will then look to put a realistic carbon reduction programme in place based on agreed scientific objectives. This will be done in conjunction with the consulting company to ensure they are both robust and achievable.

We project that carbon emissions will decrease over the next five years to **1750** tCO₂e by **2028**. This is a reduction of 5%.

Progress against these targets will be added in graphical format once the data has been analysed and reported.



The graph above shows reduction in Electricity usages since the implementation of energy efficient LED lighting and motion sensitive PIR's during 2019.

Carbon Reduction Projects

Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2019 -2020 baseline. The carbon emission reduction achieved by the LED lighting equates to **1** tCO₂e, a **0.2** % reduction against the 20**19** baseline and the measures will be in effect when performing the contract.

- Recycling of Fusion glove offcuts which are then used by another company in car dashboards
- Signed up with Enistic to compile a PPN06/21 report for which data is currently being collated
- LED energy efficient lighting installed

Polyco Healthline already had in place ISO 14001:2015 certification prior to 2019.

In the future we hope to implement further measures such as:

- Carbon reduction plan with scientific objectives
- Carbon offsetting
- Green energy
- Alternative energy sources
- Energy efficient manufacturing equipment
- Fleet being converted to all Electric by End of 2023
- Converting from Plastic packaging to paper bands on gloves
- Waste streams managed efficiently
- Monitoring of our Co2 emissions through Enistic to become compliant with PPN06/21


